**THE E9-1-1 INSTITUTE, NATIONAL EMERGENCY NUMBER ASSOCIATION,
ASSOCIATION OF PUBLIC-SAFETY COMMUNICATIONS OFFICIALS,
NATIONAL ASSOCIATION OF STATE 9-1-1 ADMINISTRATORS, AND THE 9-1-1 INDUSTRY
ALLIANCE ANNOUNCE OPEN NOMINATIONS FOR 9-1-1 HONOR AWARDS**

Washington, DC -- The E9-1-1 Institute, the National Emergency Number Association (NENA), the Association of Public-Safety Communications-Officials (APCO) International, the National Association of State 9-1-1 Administrators (NASNA), and the 9-1-1 Industry Alliance (9IA) announced the opening of nominations for this year's **Seventh (7th) Annual Honor Awards** ceremony. The organizations, representing 25,000 members in every state in the Nation, hold the awards ceremony each year where **heroes and leaders** in the 9-1-1 field are jointly honored by both the E9-1-1 Institute and the Congressional E9-1-1 Caucus.

This year's ceremony will be on Tuesday, March 16th, 2010. The Co-Chairs of the Congressional E9-1-1 Caucus are invited to present the awards. Heroism and leadership activities throughout the year of 2009 will be considered for the awards.

"The purpose of these awards is to recognize heroes and leaders whose life and work demonstrate the power of human courage and dedication to make communities safe and best respond to emergencies," said Gregory L. Rohde, Executive Director of the E9-1-1 Institute. "It is the people that make the emergency communications area strong and these awards are intended to highlight the **best of the best.**"

Brian Fontes, CEO of NENA, said, "This is one of the largest and most widely attended national emergency communication events in Washington, DC. NENA is pleased to work with APCO, NASNA, 9IA, and the E9-1-1 Institute to provide very deserving recognition of people and organizations who have **dedicated themselves to saving the lives of others.**"

"Events celebrating and honoring the achievements and service of public safety communications professionals," said APCO International Executive Director George Rice, "are excellent vehicles to ensure that **we pay tribute to the people who stand ready every day to serve those in need.**"

“NASNA is proud to support this year’s 9-1-1 Honors and encourage all public safety agencies to consider who among them has shown **leadership and dedication** worthy of recognition in the 2010 Honors Gala,” said Richard Taylor, President of NASNA.

Paul Fahey, Executive Director of the 9-1-1 Industry Alliance, said, “The 9-1-1 Honor Awards are a great chance to recognize both the public safety and industry leaders that make this **life-saving system** work so well. The collaborative public/private partnership that is 9-1-1 is on full display with these awards,”

“The E9-1-1 Institute encourages anyone who knows of a courageous citizen who used 9-1-1 to save a life or one the many dedicated public safety officials whose leadership needs to be recognized to nominate someone for these awards” said Michael Amarosa, Chairman of the E9-1-1 Institute Board of Directors. “**Lives are saved every day** because someone has effectively used 9-1-1 and because dedicated professionals work hard to ensure the 9-1-1 works and works well. These awards are intended to honor these people.”

The E9-1-1 Institute is now accepting nominations in following categories:

- **9-1-1 Call-Taker/Dispatcher Award:** This award honors the “**first responders**”—**the 9-1-1 Call-Takers and Dispatchers** who are on the front line every day. Candidates for this honor should have a proven track record of service in the field and a reputation for going the extra mile on behalf of emergency callers.
- **Citizen in Action:** The **Citizen in Action** award honors **someone** who demonstrated **exceptional bravery** and **heroism** to save a life in a critical time using 9-1-1.
- **First Responder Award:** The **First Responder Award** recognizes those individuals that **9-1-1 telecommunicators (people) call—e.g. law enforcement, fire rescue and or emergency medical service providers**—for their professionalism, initiative, creativity or diligence in assisting a person reporting and/or experiencing an emergency situation.
- **Government Leader Award (Federal / State / Local):** This award recognizes the **Federal, State or Local Government Leader** that has displayed the greatest effort to **advance the capabilities of 9-1-1** emergency communications.
- **Industry Professional Award:** The **Industry Professional Award** honors an **individual** or **organization** in the **commercial sector** that has demonstrated exceptional contributions towards the advancement of emergency 9-1-1 communications.
- **9-1-1 Technician Award:** This award recognizes the Technology Support staff—e.g. **Information Technology, GIS and other technical personnel within a 9-1-1 authority or jurisdiction** whose tireless efforts make available and maintain the critical technology systems necessary to answer, process and respond to emergency calls.
- **Outstanding 9-1-1 Call Center Award:** This award recognizes a 9-1-1 call center for overall excellence in serving the public including the handling of emergency situations reported to 9-1-1 and the deployment and management of new technology.
- **Outstanding 9-1-1 Program Award:** This award recognizes a **state or regional 9-1-1 program** for excellence in serving the public including the handling of emergency situations and the deployment and management of new technology.

A committee of the E9-1-1 Institute will review each nomination and select the winners who will be invited to attend the 7th Annual 9-1-1 Honors Gala in Washington, DC on March 16th, 2010.
