**FEES EFFECTIVE September 22, 2025**

The APCO Licensing Service offers full-service licensing with a staff experienced in application preparation and processing, FCC Universal Licensing Service policies and procedures, FCC licensing, knowledge of FCC Rules and Regulations, and the coordination process.

The fees charged by the APCO Licensing Service are for the preparation of an application for licensing by the FCC and **DO NOT** include coordination fees, which are charged separately.

**PB** - Base/mobile, mobile-only or temporary fixed - \$250 per call sign

**PF** - Permanent fixed point-to-point, point-to-multipoint and fixed receiver stations - \$500 per call sign
